The following three examples show what an order with the eBill payment method would look like in your online shop.

Your customer enters the e-mail address along with the billing and delivery address during the check-out process in the online shop. The information entered is used to query the eBill e-mail address via the network partner (look-up). This function may also be used by your payment service provider (PSP). Depending on the result of the query, this leads to scenarios 1 to 3. Following successful registration, the eBill invoice will be sent with the first online order. Further information on the various registration procedures can be found in the factsheet <u>"Overview</u> of Registration Types".

The query of the eBill e-mail address was successful. After the customer confirms the purchase by clicking on "Buy now", you or your PSP send the invoice to your network partner, who enters the invoice into eBill. The customer receives the invoice in eBill and can immediately approve it for payment.
