# 01 eBill Service for NWP

## 01—1 Basic Fee

Each NWP shall be charged with a monthly basic fee, regardless of its transactions, business activities or the number of Invoice Senders.

## 01—2 Transaction Fees for eBill Business Transactions

Transaction fee single bill		0.18
Transaction fee instalment bill	$0.18 \times \text{max. instalment amount}^1$	
Transaction fee reminder		0.18
Transaction fee credit		0.18
Transaction fee advice		0.18

<sup>1</sup> In the year 2021, four shall be the maximum number of instalments to be taken into account. Adjustments shall be expected in the next years.

Example: An eBill with three different instalment options is submitted. The eBill can be approved in one, three or four instalments. In this case the option with four instalments is relevant (max. instalment amount). In this case CHF 0.18 will be charged four times, in total CHF 0.72.

The prices apply uniformly to every Business Transaction (also for not successfully approved Business Transactions) – scale prices or volume discounts are not intended.

## 01—3 Special Services

If needed, the NWP may use the eBill support and/or consulting services. These special services shall be invoiced according to work performed.

## 02 General Provisions

### 02—1 Effective Date

This Price List shall apply as of 1 January 2021. This Price List shall replace all previous versions.

### 02—2 Currency

All prices shall be denominated in Swiss francs (CHF).

### 02—3 Tax

The amounts contained herein shall not include value added tax, withholding taxes or any similar taxes. All taxes and charges shall be borne by the merchant.

### 02—4 Invoicing

SIX BBS Ltd (“SIX”) shall draw up a total account for the eBill services utilized on a monthly basis. The payment shall be made by direct debit in CHF.
